18 In this Joint Motion, Defendants Amylin Pharmaceuticals, LLC; Eli Lilly and  
19 Company; Merck Sharp & Dohme Corp.; and Novo Nordisk, Inc., and the  
20 Plaintiffs' Steering Committee seek to extend by eight days, to May 29, 2014, the  
21 May 21, 2014 deadline set forth in this Court's Order Denying Motion to File  
22 Under Seal (Doc. 444) for the Parties to refile a motion to file under seal the sealed  
23 documents that Plaintiffs lodged under seal in support of their Opposition to  
24 Defendants' Motion for Summary Judgment. (*See Mot. to Seal (Doc. 441).*) In  
25 support of this Motion, the parties state as follows:

26 1. Plaintiffs filed their Motion to Seal (Doc. 441) on Monday, May 12,  
27 2014.

1           2.     Plaintiffs served the sealed documents on Defendants via First Class  
2 U.S. Mail on Monday, May 12, 2014.

3           3.     On Tuesday, May 13, 2014, the Court denied Plaintiffs' Motion to  
4 Seal without prejudice, ordering the parties to file a renewed motion to seal by  
5 May 21, 2014. (*See* Doc. 444.)

6           4.     Defendants first received actual notice of the documents that Plaintiffs  
7 filed under seal when Plaintiffs provided the documents to Defendants via secure  
8 File Transfer Protocols on Wednesday, May 14, 2014.

9           5.     In order to allow Defendants time to adequately review the documents,  
10 Defendants have requested that the deadline for the Parties to refile a motion to file  
11 under seal be extended eight days, to May 29, 2014.

12          6.     Plaintiffs do not oppose this requested extension.

13          7.     The requested extension will leave a renewed motion to file under seal  
14 fully briefed more than a month before the Court's July 1, 2014 hearing on the  
15 Defendants' Motion for Summary Judgment.

16          8.     The Parties submit that this extension will serve the interest of justice  
17 and judicial economy.
