GENERAL ORDER NO. 602-B

Effective March 1, 2014, General Order 602-A is superceded, and the following provisions govern the rates of associates and contract attorneys on CJA cases:

The rates of compensation for associate and contract attorneys shall be as follows:

- Attorneys with less than 3 years of experience shall be permitted to bill at the rate of \$75 per hour.
- Attorneys with 3 to 6 years of experience shall be permitted to bill at the rate of \$100 per hour.
- Attorneys with more than 6 years of experience shall be permitted to bill at the rate of \$115 per hour.

An attorney who is also a member of the CJA panel, however, shall be permitted to bill at the normal CJA rate.
