General Order No. 639

Pursuant to Civil Local Rule 40.1(c), upon the induction of a new magistrate judge, the Clerk of the Court will ascertain the average caseload for all magistrate judges and the number of cases assigned to each magistrate judge. Based upon these numbers, the Chief Judge and Presiding Magistrate Judge will determine the number of cases and, when applicable, the type of cases each magistrate judge may transfer to the new magistrate judge. Within the parameters set by the Chief Judge and Presiding Magistrate Judge, it is within the discretion of the transferring magistrate judge to determine which cases will be transferred to the new judge. Related cases will count as one case. No case that includes a filed or pending motion before the magistrate judge may be transferred. No multi-district litigation (“MDL”) cases may be transferred without consent of the assigned district judge.






