General Order No. 625-A

Good cause appearing, the Court proposes amending Civil Local Rule 5.1.a as follows:

**Civil Rule 5.1 Form; Paper; Legibility; Nature of Documents to be Filed**

- a. **Legibility.** Each document filed, including exhibits where practicable, must be in English, plainly written, or typed in double space on one side of the document, line numbered in the left margin, and letter size. Documents filed in paper format must be flat and unfolded, without backing sheet, double spaced on one side of the paper or printed or prepared by means of a duplicating process on opaque, unglazed white paper. Quotations in excess of three lines must be indented and single spaced. Typewritten text must be no less than 10-point type in the Courier font or equivalent, spaced 10 characters per horizontal inch. Printed text, produced on a word processor or other computer, may be either a proportionally spaced or a monospaced face. A proportionally spaced face must include serifs, but sans-serif type may be used in headings and captions. A proportionally spaced face must be 14-point or larger. A monospaced face may not contain more than 10 1/2 characters per inch. proportionally spaced, provided the type is no smaller than fourteen-point standard font (e.g. Times New Roman). The text of footnotes and quotations must also conform to these font requirements.


