General Order No. 626

For good cause shown and in compliance with the directives issued by the United States Court of Appeals for the 9th Circuit in *United States v. Hernandez-Estrada*, __F.3d__, 2012 WL 6054775 (9th Cir. 2012), the Clerk of Court or designee will:

1. Complete and submit an AO - 12 Report on Operation of the Jury Selection Plan to the Court's Chief Judge and designated "Jury Judge" one year after the first mailing of juror qualification forms from the Master Jury Wheel;
2. Submit to the designated "Jury Judge" any returned juror qualification questionnaires containing information that suggests doubt as to the individual's English skills so that the Jury Judge may determine whether the individual is qualified to serve as a juror; and
3. Enclose with all juror qualification questionnaires an insert stating:

Question # 4 - For Question #4, please answer "Yes" if your answer to the following two questions is "Yes." If your answer is "No" to either of the following questions, please answer "No" to Question # 4:

(1) Can you read, write, and understand the English language with a degree of proficiency sufficient to fill out satisfactorily the juror qualification form?


(2) Can you speak the English language?


Question #10 - RACE/ETHNICITY. Federal law requires you as a prospective juror to indicate your race and ethnicity. This answer is required solely to avoid discrimination in juror selection and has absolutely no bearing on qualifications for jury service. By answering this question you help the federal court check and observe the juror selection process so that discrimination cannot occur. In this way, the federal court can fulfill the policy of the United States, which is to provide jurors who are randomly selected from a fair cross section of the community.






