General Order No. 499-C

The United States District Court for the Southern District of California hereby amends Appendix II of its Criminal Justice Act Plan, General Order 499, as follows:

A committee of attorneys who are members of the bar of this Court and engage in the practice of criminal law will advise the Judges of the Court and make recommendations on:


- (1) the applications of attorneys who apply to be members of the Criminal Justice Act Panel (see Appendix I); and
- (2) any other matter that will effect the improvement of the Panel.


The committee will be known as the Criminal Justice Act Advisory Committee and will be composed of seven to nine members, one of whom will be the Chair. The members will be selected by the District Judges and will serve two-year terms, which may be renewed.

The Chair of the Committee will serve as the Criminal Justice Act Panel Representative for the Court.

IT IS SO ORDERED.


