November 23, 2012

Friday, November 23, 2012 is a holiday for the State of California. Therefore, pursuant to Fed. R. Crim. P. 45(a)(6) and Fed. R. Civ. P. 6(a)(6), it is a legal holiday for the federal court. The Court shall be closed except for the conducting of initial appearances under Fed. R. Crim. P. 5(a)(1)(A). The initial appearances shall be held at the U.S. Courthouse in San Diego from 10:00 a.m. to 12:00 p.m. There will be no initial appearances at the U.S. Courthouse in El Centro. Therefore, persons who would be presented for initial appearances in El Centro on Friday, November 23, 2012 must be presented before the Magistrate Judge at the San Diego Courthouse during the aforementioned criminal duty calendar.


Any court employee who works on November 23, 2012 to cover the criminal duty calendar will be given 8 hours of administrative leave.


December 24 and 31, 2012

The Court will be open on December 24 and 31, 2012 to handle any emergency matters. There shall be a criminal duty calendar from 10:00 a.m. to 2:00 p.m. in San Diego and at such time as shall be set by Magistrate Judge Peter C. Lewis for criminal duty in El Centro. Additionally, there will be judicial officers, pretrial services officers, and probation officers available to handle necessary matters.


However, the District Judges' staff, the Magistrate Judges' staff, the Clerk of the Court and his staff, the Chief Probation Officer and his staff, and the Chief Pretrial Services Officer and her staff are authorized to take administrative leave on December 24 and 31, 2012. Any absence will be with the approval of the head of each office or the judge whose staff requests administrative leave. Any employee of the Clerk's Office, Probation Office or Pretrial Services Office who works on December 24 and 31, 2012 will be given administrative leave to use at another time.
