

One Magistrate Judge will serve and be known as the “Presiding Magistrate Judge.” The term of the Presiding Magistrate Judge will be two years.

The Presiding Magistrate Judge will be the judge who is senior in appointment, has not attained the age of sixty-eight, has served for at least one year or more as a Magistrate Judge and who has not served previously as Presiding Magistrate Judge unless all eligible Magistrate Judges have already served in such a capacity. At the expiration of the two-year term, the next senior qualified Magistrate Judge will become the Presiding Magistrate Judge unless that judge has not served at least one year as a Magistrate Judge. In such case, the expiring term of the Presiding Magistrate Judge will be extended until the next senior Magistrate Judge is eligible. If the Presiding Magistrate Judge is temporarily unable to perform his or her duties, they will be performed by the Magistrate Judge next in line to succeed as Presiding Magistrate Judge.

The Presiding Magistrate Judge, in addition to his or her normal duties, will:

- (1) Be a liaison with the Chief Judge of the district court;
- (2) Schedule and preside over periodic meetings of the Magistrate Judges;
- (3) Coordinate the scheduling of Magistrate Judges to cover the arraignment duty in San Diego and El Centro when other Magistrate Judges are absent on leave, for conferences or otherwise; and


- (4) Arrange for the assignment of arraignment duty, petty offense and infraction calendars, and any other assigned duties on a rotating basis so that all Magistrate Judges participate equally in such assignments.

All matters of policy, space, facilities, and allocation of resources and personnel (other than the Magistrate Judges' Judicial Assistants and Law Clerks) will remain the responsibility of the District Court Judges. All matters concerning the administration and operation of the individual Magistrate Judges' chambers and calendars will remain within the discretion of the individual judges except as otherwise directed by the Chief District Judge.


