Good cause appearing, the Court amends the following Local Rules as follows:

**Criminal Local Rule 1.1.e.**

\*\*\*

- e. **Applicable Civil Rules.** The provisions of the following Civil Local Rules will apply to all criminal actions and proceedings, except where they may be inconsistent with the Federal Rules of Criminal Procedure or provisions of law specifically applicable to criminal cases:

### **Criminal Local Rule 16.1.**

“A magistrate judge may hear motions ~~at or before the arraignment to~~ preserve evidence before a case is assigned to a district judge, and thereafter as requested by the assigned district judge.”

### **Criminal Local Rule 58.2.b.**

Direct the probation ~~service~~ office of the court to conduct a presentence investigation in any misdemeanor case;

### **Civil Local Rule 4.1 Service.**

- a. Service of Process. Service of process, i.e., service of the summons and complaint, must be performed in accordance with Rule 4, Fed. R. Civ. P.

All complaints must be served within ~~one hundred and twenty (120)~~ ninety (90) days. Any extension will be granted only upon good cause shown.

- b. Failure to Serve. On the one hundredth ~~thirtieth (130th)~~ (100<sup>th</sup>) day following the filing of the complaint, or on the fourteenth (14<sup>th</sup>) day following an extension of time to serve, if proof of service has not yet been filed, the clerk will prepare an order to show cause with notice to plaintiff why the case should not be dismissed without prejudice and submit it to the assigned district judge for signature.

### **Civil Local Rule 5.1.a.**

- a. **Legibility.** Each document filed . . . must be in English, plainly written, or typed in double space on one side of the document, line numbered in the left margin with not more than 28 lines per page, and letter size. . . Printed text . . . may be proportionally spaced allowing 28 lines on one side of the document, provided the type is no smaller than 14-point standard font (e.g. Times New Roman). The text of footnotes and quotations must also conform to these font requirements. Approved templates are available on the Court’s website (www.casd.uscourts.gov) and may be amended by the Court over time as deemed appropriate.

### **Civil Local Rule 7.1.e.6**

Social Security Cases. . . Any opposition to the cross motion must be filed and served no later than fourteen (14) days prior . . .

### **Civil Local Rule 16.1.a.1 Pretrial.**

Pretrial proceedings and setting of cases for trial are governed by Fed. R. Civ. P. 16 and this rule, and by such orders as are issued pursuant thereto. The timing of the Federal Rule 16(b) scheduling order is adjusted to accommodate the Early Neutral Evaluation Conference, as allowed under Fed. R. Civ P. 1.

### **Civil Local Rule 40.1.e and g.** **Patent Related Cases and General Order 598.**

- e. **Low Number Rule, Criteria.** The clerk must promptly examine the original complaint or petition in each civil action and proceeding hereafter filed and ascertain whether any one or more civil actions or proceedings pending or any one or more currently filed appear . . . [to] (3) involve the same patent or the same trademark.,~~except where in one or both of the actions concerned, the same patent or trademark is joined with other patents or trademarks which do not cover the same or substantially identical things or devices.~~
- g. **Definition of Related Action.** An action or proceeding is related to another action or proceeding where both of them: . . . 2. Involve the same property, transaction, patent, trademark, or event . . .

### **Civil Local Rule 83.1.a Sanctions for Noncompliance**

- a. Failure of counsel or of any party to comply with these rules, with the Federal Rules of Civil or Criminal Procedure, or with any order of the court may be grounds for imposition by the court of any and all sanctions authorized by statute or rule or within the inherent power of the court, . . .

**Civil Local Rule 83.4. Standards of Professional Conduct.**

- b. Every member of the bar of this court and any attorney admitted to practice in this court must be familiar with and comply with the standards of professional conduct required of the members of the State Bar of California, ~~and decisions of any court applicable professional conduct~~ which are now adopted as standards of professional conduct of this court. ~~This specification will not be interpreted to be exhaustive of the standards of professional conduct. In that connection, the Code of Professional Responsibility of the American Bar Association should be noted.~~ No attorney permitted to practice before this court will engage in any conduct which degrades or impugns the integrity of the court or in any manner interferes with the administration of justice within the court.


**Notice of Related Patent Case.** Civil Local Rule 40.1 applies to patent cases. The parties must notify the Court of any other cases in the district involving the same patent


The effective date of the Rules is January 30, 2016.
