

William B. Enright was appointed as a United States District Judge for the Southern District of California on June 30, 1972, was sworn in on July 14, 1972, took senior status on July 12, 1990 and is still a judge on this court. William B. Enright is renowned throughout the federal judiciary as a master trial judge of exceptional skill and fairness.


