General Order No. 668

Good cause appearing, and following a public comment period, the Court amends the following Local Rule as follows:

**Civil Local Rule 83.8.e**

**Protection of the Fund.** All receipts must be deposited only in federally insured banks or savings institutions and whenever practical and feasible, all substantial sums must be placed in ~~secure funds invested in government obligations~~ interest bearing accounts or certificates of deposit that are insured by the FDIC, in government securities, or in money market funds invested in government obligations, at the direction of the Court. Efforts must be made to maximize the return on investments consistent with requirements of convenience and safety.

The period for public comment will be until March 30, 2018. Absent further order of this Court, the effective date of the Rule amendment is April 30, 2018.


